Bed Bug Treatment Customer Authorization Form

1. All unauthorized persons and pets must be removed from the apartment during treatment. Please inform our office of fish tanks that cannot be moved.
2. All food in the treatment room should be put away.
3. Please inform our office if there are any residents living in the apartment that suffer from any allergies or respiratory problems.
4. All bedding and clothing must be washed in hot water and detergent and dried in a hot dryer or send out to a commercial laundry or dry cleaners (130 degree minimum).
5. All air conditioners, blowers, HVAC in the apartment should be closed.
6. Children and pet toys should be put away.
7. Pet food and water should not be left out during treatment.
8. Bedroom closets must be emptied.
9. Remove and clean all pet bedding.
10. Remove and clean all stored articles under beds and drawers next to beds.
11. Clean our drawers next to bed and shelves behind and near beds.
12. It is generally **not** necessary to discard any furniture, bedding etc. **If** this should become necessary then you will be instructed, in writing by management to do so.
13. Mattresses and box springs must be sealed in approved bedbug or dust mite mattress covers.
14. Window treatments should be taken down and cleaned prior to service.
15. Valuables and delicate items should be put away as we can not be responsible for them.
16. All persons and pets must stay out of the area for at least four hours with the windows open. Those with respiratory problems should stay out for at least twenty-four hours with the windows open. We suggest you consult your physician prior to service.
17. Pets with health problems and birds should stay out of the area for twenty-four hours. Check with your vet prior to service.
18. Following treatment you should not touch items until it is thoroughly dried including furniture, beds, or any surface.

Due to the elusive nature of bed bugs, Company can not guaranty that an inspection and/or treatment will find any or all bed bugs, eggs etc. nor eliminate bed bugs and their eggs. Company can not be held responsible for their continued presence following treatment or inspection or for any damages resulting from their continued presence including but not limited to; 1)Expenses related to the replacement of linen, upholstery, furniture, mattress, soiling or related costs; 2)Expenses related to medical evaluation or treatment for bites associated bed bugs; 3) Damages or expenses for any claim of personal injury related to an infestation of bed bugs; 4)Loss of income claimed to be related to any bed bug bites or associated illnesses .
